Overview: Announced as part of FreightNYC


Structure: Alliance is co-chaired by NYCEDC and Port Authority of New York and New Jersey

Purpose: To ease truck traffic on major corridors by shifting freight from highways to marine highways

- Identifying and addressing the barriers, challenges, opportunities, and issues surrounding the development and expansion of a regional barge service
- 2. Identify BCOs and encourage switch to marine highway solutions

Review Trucking v. Barging costs from NYC to Boston

Task 1. Procure Consultant (Jun to Aug)

Task 2. Shipper Outreach & Diversion Analysis (June to Sep)

Task 2. Deliverable:

- "Report of Findings "to MARAD that identifies BCO clusters, business location & contact, commodity type and method of shipping, approximate freight volumes, and other relevant information with the highest probability for Container or Trailer on Barge Movement
- Diversion analysis

Task 3. Barge Service, Network, and Operations Proposal (Sep to Nov)

Task 3. Deliverable:

The technical report should be formatted into a presentation and be accompanied by cost estimates for proposed improvements, including any environmental mitigating actions/costs.

Task 4. Total Cost Model and Economic Benefits Tool (Oct to Nov)

Task 4. Deliverable:

Model providing door to door rates

Task 5. Final Action Plan (Dec)

Task 5. Deliverable:

- Technical report and presentation that summarizes the above tasks
 - Include recommended actions, the organizations necessary to make those happen, and steps/costs associated with implementation
 - Identification of additional issues needed to be addressed before the project can be started
- White Paper or Legislative Strategy
 - This will be highlight how to mitigate issues that are impediments or challenges (i.e. second HMT charge, where CBP clearance takes place, lack of CBP resources at destination etc.)

Outreach to BCOs/Shippers (Summer 2019)

- Mechanism (interviews or 'townhalls')
 - NAMHA members to decide
- Outreach deck
 - To be developed by EDC/PANYNJ
- Information to collect
 - Annual Tonnage
 - Origin/destination pairs
 - Routing information
 - Costs of trucking
 - Description of truck fleet/type
- Schedule for interviews/'townhalls'
 - NAMHA members should complete outreach by late summer/early fall 2019
